Further Planning towards Regional and Area Addictions and Mental Health Service Organizations

February 24, 2014

On February 24, the South East Local Health Integration Network (LHIN) Board of Directors, having heard from our clients/patients and front line clinicians, agreed to move forward towards improving the provision of a high quality, accessible addictions and mental health system of care.

This next phase of planning for the Addictions Mental Health Redesign (AMH) in the South East is a collaborative process that will enable stakeholder participation and engagement through committees focusing on clinical services, financial costs, and governance structures.

The preferred platform envisions an option where area organizations offering a common basket of services across the South East work in concert with regional AMH supports.

This model was developed in support of the Ideal Client Journey, a collaborative creation that originated from engagement sessions organized with clients/patients and care providers throughout the region and validated through a further engagement session attended by over 180 of those mentioned.

The South East LHIN Board, recognizing the value, ownership and pride that local agencies have in their organizations and following the review of the extensive community engagement, directed South East LHIN staff to continue planning and engaging with the community to explore the implications of the preferred option. Further decisions on the planning processes will be brought back to the board on March 31.

The vision of the AMH redesign project is "to ensure patients receive the right care at the right time, enhance capacity of providers and the system, and reduce stigma." This vision aligns well with the South East LHIN vision that also seeks to enhance the capacity of providers within an integrated, regional system and is part of the implementation of the South East LHIN's IHSP3, *Better Integration, Better Health Care* and aligns with Ontario's Action Plan for Health Care.
